CCUSBC 19th ANNUAL WOMEN'S CHAMPIONSHIP TOURNAMENT RULES

- 1. ELIGIBILITY: Tournament is open to all Women sanctioned through USBC and CCUSBC. CCUSBC Memberships will not be sold at the tournament site.
- **2. ENTRIES:** A bowler may enter the Team Event twice, subject to the following:
 - A. Participants bowling in 2 Team Events, 1 Doubles, and 1 Singles; if bowl two team events, they must be bowled on different squads.
- B. In order to place more than once in the prize list for team position standings, at least two (2) players in the team lineup must be different. (USBC Rule 315b, 1)
 - C. A bowler's first appearance in each event counts towards the all-events total. (USBC Rule 315d)

3. COPPER COUNTIES LEAGUE AVERAGES:

- A. USBC Rule 319a, 319b, 319c and 319e apply.
- B. USBC Rule 319a2 (10 pin rule) applies: When the previous Season's average is used, and at the time of bowling an entrant has a current average for 21 or more games that is 10 pins or more higher than the prior season's CCUSBC's Association book average, then CCUSBC's Association League current average must be used.
- C. Participants shall use their highest 2023-2024 CCUSBC Book Average based on a minimum of 21 games. If no 2023-2024 CCUSBC book average is available, participants will use their highest CCUSBC current 2024-2025 average based on 21 or more games. All others shall be assigned an average of 220.
- D. If a bowler was required to switch his bowling hand due to injury or medical requirement, the bowler may request an average adjustment from USBC to use the most current average of 21 games of more with the uninjured hand as long as the medical requirement still exists.
 - E. Handicap shall be based on 90 percent of the difference between the entrants average and 220.
 - F. REPORTING AN INCORRECT AVERAGE MAY SUBJECT THE ENTRANT TO DISQUALIFICATION.
- 4. **PRIZES**: Prizes will be awarded at a ratio of 1:5 entries in each event except for the optional events. All optional events will be awarded at a ratio of 1:8 entries. Prizes will be awarded after verification of averages. Checks are expected to be mailed within 10 business days upon completion of the competition.
- **5. SUBSTITUTES:** Substitutes shall be allowed for just cause. Verification of a subs average must be in the possession of the Tournament Director one-half hour prior to the scheduled bowling time, if possible. A Substitute shall not be required to reimburse the original entrant with any entry fee. Nor shall he be expected to give the original entrant any prize money or award he may win. Optional All Events entry fee may be transferred to a substituting bowler provided the original bowler has not competed in any event prior to the substitution.
- **6. REPORT TIME**: Bowlers will report to the check-in table 30 minutes prior to their scheduled squad time. The team captain may check in his team if all members are present. USBC membership must be verified at check-in.
- 7. APPEALS: The decision of the Tournament Director shall be final unless an appeal is made in accordance with USBC Rule 329. PROTESTS MUST BE FILED IN WRITING WITHIN 24 HOURS.
- 8. REFUNDS: No tournament fees will be returned after the start of the tournament except at the discretion of the Tournament Director.
- 9. PAYMENT: Personal checks returned for non-payment will be assessed a \$40.00 service charge.
- 10. ENTRY CLOSING DATES: Entries must be postmarked on or before MIDNIGHT, November 1, 2024.
- 11. CONTACT/MANAGEMENT: Tournament Director for this tournament is Association Manager, Bev Pederson ccusbcassociationmanager@gmail.com. She has supervisory control of all technical parts of the operation of the tournament in accordance with USBC Rule 303. Anything not covered in these rules will be governed by USBC rules.
- 12. DRESS CODE: Participants must wear appropriate bowling attire. Shirts will have a "butterfly" type or "mock high neck" collar with sleeves, or be an official bowling Jersey. * NO T-SHIRTS, NO EXCEPTIONS. Hemmed shorts (must extend beyond bowler's fingertips when standing relaxed and arms are extended downward at the bowler's side) and jeans (with no holes) will be allowed. Prohibited attire includes, but is not limited to, t-shirts, tank top shirts, cut offs, short shorts, headgear (allowed for medical reasons only), sweats or spandex. Shirts with inappropriate or vulgar pictures or writing will not be allowed and is left up to the discretion of the Tournament Director. Failure to comply means that bowler will not be allowed to bowl and cause forfeiture of entry fees. Tournament director's decision as to appropriateness of attire will be final.
